## President Report – Wendi Zwaduk

Wendi Zwaduk reported to the Friends the following informational items:

### • Informational Binders in Friends Office and Sorting Room

Wendi informed the group that she created binders, for the Friends Office and sorting room (in the LaGrange Municipal Village Building), for the following documents: Friends of EPLS Keystone Bylaws; Business Permit from the Ohio Secretary of State Office; Organization Paperwork for the Ohio Attorney General's Office; Employee ID Number (EIN) and tax information for the Internal Revenue Service; Friends Articles of Incorporation; and Friends of Lorain County Libraries membership applications and fees (outlined for comparison purposes). All binders are available for Friends of EPLS Keystone Library reference.

### • Keys to the LaGrange Municipal Village Building

Wendi explained to the group that there is only one key to the sorting room (not storage room) in the LaGrange Municipal Village Building. Municipal procedure is to sign out 1 key through the police department. The Village does not carry spare keys, nor will they allow the duplication of them. Also, keys cannot be borrowed from the building administrator. This is a safety practice. The building administration will open and close doors in the building upon request. Please note that the Village Building is low staffed on Fridays. They prefer that the community members do not use the lobby and rooms on that particular day. Events are usually scheduled on Saturdays and Sundays. They would like the Village Building to look presentable for events on the weekends. A key to the outdoor doors is not available for public use.

## <u>Treasurer Report – Marcia DeJonge</u>

Marcia DeJonge reported on the following treasury transactions this past month: There were deposits of \$55.00 for membership dues and \$50.00 for donations from the sorting room for the Fall Book Sale. Expenses were \$50.00 for the state filing fee and \$31.09 for a bank fee (new checks). The total balance is \$7,496.87.

# Sunshine Committee Report – Linda Chapin

Linda Chapin reported that a sympathy card was sent to the family of Peggy Malone, member of the Friends of EPLS Keystone Library. A donation of \$50.00 was given to the Keystone Athletic Team Sports (KATS) in memory of Ken Sooy. Linda read a note from Ken's family.

### EPLS Director Report – Jennifer Starkey

Jennifer Starkey thanked the Friends for their presence at Debby Krejsa's Open House/Retirement Farewell on July 31, 2024 in recognition of her years of service as Keystone Branch Manager. Jennifer also thanked the Friends for their help with the Back-to-School Backpack Giveaway this summer. Jennifer mentioned that EPLS' online library catalog will have a new look the end of October. It will also work differently, but will be more user friendly.

Jennifer then introduced the Keystone Library's new Branch Manager Carrie Tilley, who came aboard on August 1, 2024. Carrie was a member of EPLS' Central Library for a number of years and was Manager of Information Services for three years. Carrie Tilley stated that the library patrons have been welcoming to her. ### **OLD BUSINESS**

### **Book Collection and Sorting**

Paula Pietch reported on the number of books that were sorted and boxed by the sorting crew, during the summer months, in the sorting room at the Village Municipal Building: June (2,898); July (1,350); and August (547). The number of books carried over from last year's sale is 472. The total count (including the months of April and May) is 7,357.

Following Paula's report, Theresa Henderson mentioned that there is a religious organization in Ashland, Ohio that will accept religious books, bibles, and study guides that won't sell at our Friends Fall Book Sale. These religious articles are then donated to another religious organization in Michigan for disbursement nationwide.

### 2024 Fall Book Sale (November 14 – 17, 2024)

The Friends need to set up the volunteer schedule for the book sale ASAP. Kathy Burrer has all the membership contact information. We just need a chairperson for scheduling the volunteers. Kathy volunteered to organize the food that is provided by the Friends during the book sale. Set up for our book sale in the village gym starts Tuesday, November 12, 2024.

### Follow up on Raffle for Back-to-School Backpack Giveaway

Wendi Zwaduk reported that there were 93 entries (7 were doubles) in the raffle drawing. Winners consisted of 1 girl and 2 boys. Conducting the raffle during the summer reading program captures more participants. We had 2 more entries than last year. Next year, it would be helpful if we asked for a volunteer to specifically do more advertising for the raffle.

### <u>Evergreen Replacement Tree – Update on Planting of Tree</u>

Wendi Zwaduk reported that Pandy's Garden Center will plant our Baby-Blue-Eyed Spruce in the Fall. Once it is planted, the Friends can do a dedication with a plaque and photo of our tree on it. The plaque will hang by the fireplace in the library. Wendi will order the plaque from Etsy.

### <u>Advertising for the Keystone Library Branch – Wendi Zwaduk</u>

Wendi was unable to update the Friends' Facebook Page with her other responsibilities. There were posts about book collection and donations, and general posts about books and libraries on the page. If anyone is interested in helping out with the advertising, please let Wendi know.
